Drawing on real examples from the TIP consortium, we will examine scholarship in practice – how do we build a bridge between business practice, teaching, and research? And just what are we certain about, when it comes to social impact management? What do we feel the greatest need to understand still, in order to effectively teach about the topics we care about?</p>

Jain</p> <p>Two TIP projects, at Case Western and SP Jain, are specifically designed to engage a broad constituency in change efforts. Case Western will describe their efforts to shift a whole school/culture, sharing learnings and insights from their Appreciate Inquiry Summit (October 2005) and their overall efforts to create a “school within the school.” SP Jain will address the integration of their DOCC projects in the MBA experience, and the “how and why” behind the creation of their BENEX consortium, a cross-sectoral group of NGOs and corporations, working to explore real-life social impact management together with faculty at SP Jain.</p>
